VOID IN PUERTO RICO, QUEBEC, AND WHERE PROHIBITED BY LAW.

PROMOTION PERIOD: The 80Eighty® Dream Car Giveaway® #46 (the “Sweepstakes”) begins at 12:01:00 a.m. Mountain Standard Time (“MST”) on April 26, 2021 and ends at 11:59:59 p.m. MDT on June 20, 2021 (the “Promotion Period”).

ELIGIBILITY: Open to permanent legal residents of the 50 United States, District of Columbia and Canada (excluding Quebec), 18 years of age or older at time of entry and have a valid drivers license. Void in Puerto Rico, Quebec, U.S. Territories and where prohibited or restricted by law. Employees, board members, advisory committee members, directors, officers, or agents of 80Eighty® LLC (the “Sponsor”), Marden-Kane, Inc., (collectively the “Releasees”) their affiliates, subsidiaries, advertising and promotion agencies, or any other suppliers to Sponsor and the immediate families (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and persons living in households of each, whether or not related are ineligible.
